Message from the Secretary General and President

As Secretary General and new President of AnimalhealthEurope (since June 2022) we invite you to browse through our annual report to learn more about our efforts to raise awareness on why animal health matters, and how our members are prioritising the development of innovative solutions to ensure holistic animal care and sustainable food systems during this time of geopolitical crisis and instability.

Our core focus: Application of the new EU rules on veterinary medicines

Remaining at the forefront of our work throughout this past year, the January 2022 application of the new EU Regulations on Veterinary Medicines and Medicated Feed was a priority for us and our entire membership. It is safe to say both our national associations and company members have been fully occupied with implementing the various changes coming with the Regulations, and it hasn't always been smooth sailing. Despite the intended objective of reducing administrative burden for industry to ensure wider availability of medicines across Europe, significant delays and technical

hiccups with the new databases and processes have so far created additional work. We hope to see the challenges resolved as we move forward into 2023.

Our priority focus areas: One Health

With One Health as one of our priority focus areas, we have been working this year to draw attention to the need for the great impetus created around the One Health concept to now be put into action. We were very pleased to have the Director General of the World Organisation for Animal Health Monique Eloit speak at our annual conference on the Quadripartite's One Health Action Plan that was later published in October.

Created in 2021 in the aftermath of the COVID-19 pandemic to prevent, detect, and rapidly respond to health emergencies, we joined the EU's Health Emergency Preparedness and Response (HERA) Joint Industrial Cooperation Forum in 2022 to serve as the voice of the animal health industry. We were also pleased to see our request

for a One Health stakeholder platform answered when we were invited to join the existing EU AMR One Health Network. These actions were complemented by the creation of a new One Health Directorate within the DG SANTE structure at the European Commission, a step in the right direction for concrete action.

Our priority focus areas: Sustainability

As ever, sustainability remains a priority focus with a raft of new policies coming from the EU institutions looking at the sustainability of our food systems amongst others. We joined the Commission's newly created Advisory Group on Sustainability of Food Systems to promote the central role animal health plays in efficient and sustainable food production. To ensure better understanding of the importance of continued veterinary medicines availability, and their role in sustainable farming, we were also active in the Domestic Advisory Group on the UK-EU Trade and Cooperation Agreement to ensure continued supply of animal health products both in Great Britain and Northern Ireland.

Our priority focus areas: Innovation

AnimalhealthEurope officially moved into the areas of in vitro diagnostics, digitalisation and Big Data in 2022, with the formation of dedicated working groups. Work in this area supports the general move over the past years to focusing on earlier detection of disease for more holistic animal health care. Our work continued throughout 2022 within the Secretariat for the International Research Consortium on Animal Health, and some of our company members have been active in projects to respond to vaccine development requests, particularly for African Swine Fever. In-depth analysis of disease control tools gaps was published by our DISCONTOOLS project manager in the second half of the year with a call to focus on five research priorities for animal health over the next years to help deliver a sustainable and healthy planet. Priority areas for innovations are vaccinology, antimicrobial resistance, climate mitigation and adaptation, digital health, and epidemic preparedness.







Better animal health for better animal welfare

Animal welfare a priority for Europe

A whopping 94% of survey respondents in the 2016 Eurobarometer on Animal Welfare believe it is important to protect the welfare of farmed animals. Whatever elements of animal welfare this view is based on, it's clear that animal welfare awareness when it comes to food production has increased notably in recent decades in Europe.

People hold a similar view when it comes to the welfare of companion animals, in fact, 74% of those surveyed believe the welfare of companion animals should be better protected than it is currently.

With that in mind the European Commission has been reviewing the fitness of current EU legislation with the objective of revising it and updating it with the latest scientific information and also societal demand.

Animal health, a prerequisite for animal welfare

Animal health products play an important role in maintaining high standards of animal welfare. Vaccines and parasiticides provide the means to prevent disease spreading amongst livestock, as well as among pets. Where bacterial infections occur, antibiotics can help to control them. And diagnostic tools are also helping to ensure that the right diagnosis is given early on so that the appropriate treatment options can be given to quickly remedy illness.

Animal health is recognised as being essential for animal welfare in the EU Regulation on Transmissible Animal Diseases, also known as the Animal Health Law, and it is also indirectly referenced in the internationally recognised principles of animal welfare known as the 'Five Freedoms'.

Free from fear and distress The science is also developing in this area, and many scientists and animal welfare academics now talk about the Five Domains of animal welfare, which essentially include these same five elements, but with a greater focus on the mental state of the animal.

Animal welfare and disease

Our concern for animal welfare is, in a first instance, centred around disease prevention, control and treatment, but we recognise that ill-health can be the result of a complex combination of factors. Some are intrinsic, such as genetic make-up; some are external, such as living conditions, food, or contact with wildlife; some are environmental, including weather or the presence of air or water-borne diseases. No matter the circumstances however, animals just like people can get sick and in the instance of illness, it is important that veterinary care is given so that the appropriate treatment can be advised to avoid animal suffering.

The right conditions can of course help minimise the risk of disease, but they can never prevent it completely. This is why animal welfare requires good animal husbandry practices, responsible pet care, access to veterinary support, and animal vaccines, medicines and other healthcare means.

A better life for pets

Today, advances in animal healthcare are supporting a better life for our pets. With pets living longer and often being treated as part of the family, there are growing occurrences of lifestylerelated diseases such as obesity, diabetes, arthritis, and cancer. Developments over the past years have brought a range of therapeutic options to address these concerns, ensuring a better life for pets.

Better welfare for farm animals

Increasingly, consumers wish to know that the food they consume has come from animals that have enjoyed a healthy life and therefore a high standard of animal welfare. Farmers have a duty of care towards these animals, making sure they are safe, fed, happy and healthy. New animal health monitoring tools for farms are helping farmers to keep a closer eye out for signs of ill health or discomfort, so that care can be given before illness strikes, or to help stop it spreading further.

Contributing to the review of EU animal welfare legislation

With the review of EU legislation on animal welfare, the European Commission is expected to publish a package of four proposals on welfare during transport, at the time of slaughter, on keeping and breeding, as well as on an animal welfare label by the end of 2023. And for the first time, the legislation will also cover aspects of pet welfare. AnimalhealthEurope will continue to play an active role in the review as member of the EU Platform for Animal Welfare, highlighting areas where animal health solutions can contribute. With today's expanding toolkit for veterinarians, farmers and other animal guardians, our industry offers connected health care for better welfare and more holistic animal management.


